• Operation, maintenance, and improvement of: (a) a work of improvement for water based recreational purposes; or (b) other work of improvement that could have been built for any other purpose authorized law.
3. The proposed Conservancy District comprises the whole of Jefferson Township, Carroll County, Indiana.
4. The place of the hearing will be the Circuit Court of Carroll County, 101 West Main Street, Delphi, Indiana 46923.
