NOTICE OF 30-DAY PERIOD FOR PUBLIC COMMENT

Preliminary Findings Regarding the Renewal of a Federally Enforceable State Operating Permit (FESOP) No. F015-25494-00027 for Indiana Packers Corporation in Carroll County FESOP Permit No. F015-25494-00027

The Indiana Department of Environmental Management (IDEM), has received an application from Indiana Packers Corporation located at Highway 421 South and County Road 100 North, Delphi, Indiana 46923 for a renewal of their FESOP issued on August 4, 2003. If approved by IDEM's Office of Air Quality (OAQ), this proposed renewal would allow Indiana Packers Corporation to continue to operate their existing pork rendering and processing plant. If this source were to operate 24 hours a day, 265 days a year, it would have the potential to emit: 166.64 tons of PM, 169.82 tons of PM10, 249.28 tons of SO2, 101.96 tons of NOX, 152.86 tons of VOC, 69.35 tons of CO, 452.0 tons of H2S, 9.20 tons of ethylamine, and 10.76 tons of total HAPs. This source is the source to emissions that are greater than 39.84 tons of PM, 38.82 tons of PM10, 51.28 tons of SO2, 85.06 tons of NOX, 21.60 tons of VOC, 69.35 tons of CO, 45.20 tons of H2S, 0.92 tons of ethylamine, and 2.48 tons of total HAPs.

This draft FESOP does not contain any new equipment that would emit air pollutants, and no conditions from previously issued permits/approvals have been changed.

How can you participate in this process? The date that this notice is published in a newspaper marks the beginning of a 30-day public comment period. If the 30th day of the comment period falls on a day when IDEM offices are closed, the date that this notice is published is deemed to be the 30th day of the comment period. You may request that IDEM hold a public hearing about this draft permit. If adverse comments concerning the air pollution impact of this draft permit are received, with a request for a public hearing, IDEM will decide whether or not to hold a public hearing. IDEM could also decide to hold a public hearing in addition to, or a public hearing. If a public hearing or meeting held, IDEM will make a separate announcement of the date, time, and location of that hearing or meeting. At a hearing, you would have an opportunity to submit written comments and make verbal comments. At a meeting, you would have an opportunity to submit written comments, ask questions, and discuss any air pollution concerns with IDEM staff.

Comments that are most likely to affect final permit decisions are those based on the rules and laws governing this permitting process (326 IAC 2), air quality issues, and technical issues. IDEM does not have legal authority to regulate zoning, odor or noise. For such issues, please contact your local officials.

What will happen after IDEM makes a decision?

Following the end of the public comment period, IDEM will issue a Notice of Decision stating whether the permit has been issued or denied. If the permit is issued, it may be different than the draft permit because of comments that were received during the public comment period. If comments are received during the public comment period, the final decision will include a document that summarizes the comments and IDEM's responses to those comments. If you have submitted comments or have asked to be added to the mailing list, you will receive a Notice of the Decision. The notice will provide details on how you may appeal.

If you disagree with that decision, the final decision will also be available on the Internet at the address indicated above, at the local library indicated above, and at the IDEM file room on the 12th floor of the Indiana Government Center North, 100 N.
